Showing fee:

\$85. This fee is non-refundable. It guarantees you one reserved exhibiting spot at the event.

INCLUSION IN OFFICIAL ARTCRAWL LISTING FOR 2018:

The showing fee for this event does not make your name inclusive of the official ArtCrawl listings for this year's event. It is a separate listing conducted by the ArtCrawl Headquarters. If you are one of the selected artists, you may later choose to have your name included in the official ArtCrawl 2018 listing (official ArtCrawl flyer, website and invitations) as an official Guest Artist for JoMar Visions' participating building. It is not required, it is only an option. There is no information yet of how much the inclusion would be for this Houston ArtCrawl 2018. When more information arrives from the ArtCrawl headquarters people, the selected artists will be given the option of having their names listed or not. There will be a deadline from ArtCrawl and a form to be filled online, and although JoMar Visions will work as intermediary on having all forms and moneys collected to be given to them; JoMar Visions will not be responsible if an artist doesn't deliver their payments and forms filled on time. Each artist is responsible for completing the form and mailing/deliver it with their checks before the cutoff date (to be announced). JoMar Visions will inform its participating artists when we have information about their deadline.

Wall choice:

Is done on a first come first serve basis on the hanging date. Each artist will have a portion of wall where he/she can hang as many pieces they wish. The exhibiting wall will be approximately 6' wide by 14' tall. Space for table or pedestals (5) is also available if any of those are preferable to having a wall. Sales:

JoMar Visions will process all sales and receive **10%** commission of the retail selling price of any sold item.

The items listed may not be sold for less than the retail price indicated unless approved by artist. If any item is sold for more than listed price, artist will receive his/her share of the higher selling price. JoMar Visions will pay the artists for any item sold, within a month from the event, after the moneys paid from the clients have cleared.

Deadline for applications:

Whenever the exhibit is full and all spaces are taken.

ARTWORK Hanging DATE: Wednesday 14th of November at 4-8pm

Please don't be late for hanging your work. You're responsible for hanging your own work, you hang as many

pieces you want and you lay it out as you wish on your space. You're responsible for the take down too. THERE WILL BE NO OTHER HANGING DATES AND TIMES SO MAKE SURE YOU CAN MAKE IT OR HAVE SOMEONE TO COME AND DELIVER AND HANG THE ARTWORK FOR YOU.

All pieces must be wired on the back and ready to hang. JoMar Visions reserves the right not to display work that is not of professional quality or ready to hang. Paper pieces should be framed or profesionally mounted as an end product for a client. Each piece should also have a tag with the name of the artist and the name of the piece so we know which one is which when we do our own tags for each piece.

If shipping is involved in getting the consigned material to and/or from JoMar Visions, the artist will

be responsible. All artwork shall be packaged and shipped in accordance with shipping industry standards for item shipped. Artist shall be responsible for damage to artwork caused from improperly packaging of item (framed work etc.). Shipping shall be done using certified mail or other approved shipping methods (FedEx, UPS, etc.) that provide for tracking and/or require a delivery signature. All artwork shall be insured for its purchase price. Artist shall not deliver any artwork by COD.

Although we will maintain every effort to keep the work in perfect condition, JoMar Visions will not be responsible for any damage or loss, the artist should have their work insured as they see fit.

Take Down Date: Sunday 18th of November after all guests are gone

No art is to be taken down while there are still guests present. A member of JoMar Visions team will let everyone know when it's an appropriate time to take down the artwork.

If any items are left behind after the take down date, items will be assessed a \$10 per day rental of space fee unless a previous agreement has been made upon by JoMar Visions and Artist. Artwork will be put up for auction if not picked up within 2 weeks of end of Exhibit, from JoMar Visions Studios. All proceeds to be donated to the JoMar Visions Studios upgrade fund and art programs.

Food and Drinks:

All artists will contribute with food. JoMar Visions will provide bartender, drinks and paper and plastic disposables.

Each artist brings a little something for the food table.

Tags:

A word file will be sent after the hanging date for the artist to fill up the data for each piece. That file needs to be sent back to us. JoMar visions will print all the tags for the exhibit.

Cancellations:

Showing fee is non-refundable.
